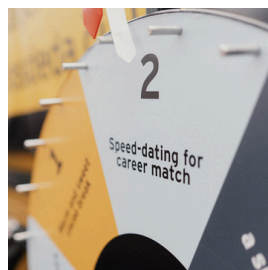

- N. B. for non-EU/EFTA applicants: The gap since your completed secondary degree should not exceed 5 years
